C. SUPPLEMENTARY SPECIFICATIONS

ART. 2 DESCRIPTION :

The STATION LE SEAU MONTEBERG RALLY (rally B) will be run over two different Special Stages fully on hard tarmac surface ; SS Busseboom with a distance of 6.25 km and SS Dikkebus with a distance of 7.53 km will be each run four times. The total distance of the Event is 174.02 km of which 55.12 km competitive sections.

ART. 4 ENTRIES :

Entries will only be accepted through our online system on www.monteberrally.com

The online entry form should be sent by mail, fully and correctly filled out and signed, to the address below before the 23rd of August 2020 at 23:59h.

The organisers want to state that the competitors are responsible for correctly filling out the entry form. Incomplete entry forms will not be accepted and will be seen as invalid registration.

Foreign Competitors need to be in possession of a valid national license and authorisation of their ASN.

Maximum 150 crews will be accepted to start the Event. The organisation keeps the right to raise the maximum amount of crews, depending on the number of entries.

Priority will always be given to the competitors who paid their entry fee before the Administrative Checks.

From the moment the maximum number of allowed entries is reached, a waiting list will be created. The complete list of the pre-entered competitors will be send to the secretary of the VAS for confirmation.

If the maximum number of competitors is not reached, competitors will still be allowed to enter on the day of the Administrative Checks, but the entry fee will be raised by 20%.

The organiser has the right to refuse an entry of a competitor by a handing over a motivation letter to the Board of the Stewards.

ART. 5 ENTRY FEE, INSURANCE, START AUTHORISATION:

Entry fee:

The entry fee is **126,00 €** and has to be paid to the organisation.

All event documentation such as roadbook, start numbers etc. are included in this fee.

The payment has to be done by transfer to the bank account with number **320-0062440-42**, IBAN: BE77 3200 0624 4042, BIC: BBRUBEBB on name of Superstage vzw with mention "name driver and codriver MBR 2020", and this before the **23rd of August 2020**.

Start Authorisation:

The Steward on duty will give a start authorisation to each crew who duly paid the insurance fee and the working cost to the federation (VAS VZW).

The total fee will be **€99,00**. This sum has to be paid in cash at the Administrative Check to the Steward on duty.

Competitors with a RACB license will have to pay an administrative fee to the federation with an amount **€60,00**, to be paid to the Steward on duty.

At the Administrative Checks each team will be asked to pay **€5,00**. This amount goes directly to the security posts.

It is also possible to pay by card via a terminal which will be provided by VAS. This is only valid for the start authorisation, not for the entry fee which has to be paid to the organiser.

ART.6 ELIGIBLE CARS:

All participating cars should be conform to the technical and safety specifications of the VAS-regulation. The participating cars should be conform to the prescriptions of the Highway Code and so be in possession of a valid conformity card and insurance card.

ART. 14 PUBLICITY:

The competitors should put all publicity, imposed by the organiser. In case of non-respecting this rule a fine equal to the double of the entry fee will be applied.

The compulsory publicity has to be put on the locations imposed by the organisers from the technical scrutineering control until the end of the Event.

ART. 16 RECCE:

Recce is authorised on Saturday the 29th of August 2020 between 16.00 and 20.00 hour with standard cars without safety cages. Maximum 2 passages per competitor which will be controlled by the organiser.

The organisers inform the competitors that the Traffic Regulation should be followed at any time, so also during the recce.

ART. 17 OFFICIAL NOTICE BOARD :

The official notice board will be at the City Hall of Poperinge, Grote Markt 1 (8970 Poperinge)

ART. 19 TIMECARD

A new time card for the next section will be handed over at TC 2B – 4B – 6B REGROUP OUT.
The timecard of the last section needs to be handed over at TC8A Parc Ferme IN.

ART. 22 SERVICE AREA / REPAIRS

- The service park will be accessible from 16h00 on Saturday the 29th of August 2020
 - Registration at the entrance of the service park is compulsory and this will be located in the Hondstraat, Poperinge. The organisation shall attribute a place in the service park according to the plan.
- **Considering the risk of fire in the service park every individual service spot has to be equipped with an inspected fire extinguisher ABC with a minimum of 6-kilogram following norm EN 3-7. This means that every place where a car will be serviced should have a valid extinguisher.**
 - **A competitor will be disqualified if he does not comply to one of the above rules.**
- **Teams who would like to service together in the service park should contact office@ypresrally.com, before the 24th of August 2020.**
 - Trailers are not allowed in the service area. Trailers have to be located on the parking lane of the Ring of Poperinge (Noordlaan, Oostlaan, Zuidlaan, Westlaan). A map can be found on our website.
 - For each participating car, space will be provided for one rally car and one service car who has to have the SERVICE stickers glued behind the front window at all times before and during the Event.
 - An extra authorization SERVICE can be bought for €50 per ticket. When there is a car without authorization within the service zone, a fine will be given with total amount of €125. (VAS chapter 6 article 22)
 - Have respect for the residents. They must be able to enter their garage at all times.
 - There is a maximum speed of 30 km/h in the service zone.
 - The road section in the service park should remain free at any time.
 - Each team has to use compulsory a ground sheet. VAS standard regulation (chapter 6 art 22)
 - When one of these rules is not followed, the driver of the team which ignored the rules will be disqualified from the race.

ART. 24 REFUEL AND PROCEDURES

Refuelling has to be done in the REFUEL ZONE provided on the connecting road: PMO – Vlaanderenlaan 59, 8970 Poperinge – indicated in the roadbook on 2,74 km after the stop of KP BUSSEBOOM. It's prohibited to fuel up outside of the REFUEL ZONE.

ART. 26 ALCOHOL CONTROL

Each person (driver, co-driver) who participates to an event organised under the responsibility of the “Vlaamse Autosportfederatie (=VAS)” could face an alcohol control before and/or during the event. This is executed by the appointed judge, mandated by the VAS. The sports federation applies a zero tolerance (0.00 sports regulations Chapter 4 General Regulations Art. 2 page 6). This means that the alcohol content must be 0.00 per mil. If the first test is positive, a second test is carried out with the 'pipe' so that the correct amount is known. In case of a positive result (driver and/or co-driver), the team will immediately go out of competition. Breathalyzer used : Alco-sensor-FST serial number: 071333 and 071328, with valid calibration certificate issued by the Belgian measuring institute.

ART. 28 FINAL SCRUTINEERING:

The final scrutineering can be held at: Worldkarts Poperinge, Europalaan 5, 8970 Poperinge.

ART. 29 PRICES AND TROPHIES:

The price-giving will take place at 20h00 at Worldkarts Poperinge, Europalaan 5, 8970 Poperinge.

Trophies will be handed over to the first three of each division and the winner of each class, and first lady.

ART. 31 SUPPLEMENTARY PRESCRIPTIONS:

These supplementary regulations are based on the standard VAS-rally-rallysprint regulation. All not included items will be covered through the VAS regulation and the national sport code of the RACB.

Damage caused by a competitor to third parties or another competitor, should be reported immediately to the organiser before, during or after the Event.

In case of an accident, the competitor is obligated to contact the technical commission to have a final scrutineer before the next section. **This control will take place in the service park.**

Tracking systems will be placed in the car on Sunday the 3rd of May 2020, just before passage over the starting podium. Please allow five minutes for this before passing over the podium towards the first special stage.
